<u>BOCS Presentation</u> – The BOCS meeting was July 13th. Janene reported there was great community support for the demand for "the BOCS to direct the County Executive to create and implement a policy requiring all Capital Improvement Projects and other plantings on county land to require100% Virginia native plants, with approval by Watershed Management required for any exception."

Speakers, including Janene and David extolled the benefits of native plants for water conservation/cleanliness, insect/wildlife habitat, and overall environmental health.

The organizations who participated will continue to meet to address code enforcement, design standards and plant lists.

<u>Education</u> – Jamie is in conversation with several Speakers for future presentations.

<u>Social-</u> Leslie reported the Book Club read Janene's book <u>Lead Like a Master Gardener</u>. The Memorial Dedication will be at the Teaching Garden September 25th at 10:30.

<u>Master Gardener Class</u> – Nancy reported that scholarships for MG training applications are available now. The state office will offer one partial scholarship and MGPW will offer two partial and one full scholarship.

Information sessions will be offered the last week of August. Classes begin September 14th. The Hybrid class using Zoom and Canvas will have five live sessions.

<u>Teaching Garden</u> – Leslie reported a record number of volunteers for composting and weeding the TG.

The Mushroom class, by Adam Downing, State Arborist, had 40 attendees.

The Fall Plant Sale will be the first Saturday in September.
