# **Education/Social** No events planned yet.

**Teaching Garden** The 6 May plant sale was very successful. Over \$5,000 in sales. Sold mostly native plants. Leslie will still take plant donations – especially high value native plants.

 $\underline{\text{VGMA}}$  Registration for International Master Gardener College in Kansas City – June  $7^{\text{th}}$  through June  $22^{\text{nd}}$ - is still open.

MG college at Blacksburg is still open. The Tree Steward program is full.

VMGA will be deciding soon who receives a scholarship award to MG college.

<u>VCE</u> Thomas Bolles officially introduced Valerie Huelsman as the new Natural Resources Specialist & MG Coordinator.

Thomas would like to re-invigorate the Diversity & Inclusion committee. The MG organization has not achieved parity with the local population. Local area is roughly 27% Hispanic, ½ % Native American, 8% Asian, 15% African American, 33% White, 10% two or more races. Thomas was given some names to reach out to in the coming weeks to ask it they are interested in joining the committee.

<u>Community Garden Grants</u> St. Nicholas Academic Community was awarded \$500. Christina will check and see if Nancy Berlin conducted a site visit. We need to request an MG to be the POC for St. Nicholas. Nancy Berlin had done this in the past. St. Nicholas needs to come to the Board next year to summarize their garden accomplishments with our funds.

Janene will contact Linda Gulden to get a summary of the Garden Grant from 2022 (Monastery wildflower meadow)

## Old Business/New Business

Once VMGA decides who gets a scholarship for MG college, the MGPW board needs to decide if we are going to offer a partial scholarship to a Prince William MG that was not selected for a VMGA award. We have some potential nominees that were submitted by Nancy. Christina has been talking to them. Need to determine how much the scholarship will be and from what funding source. Can the MG training scholarship committee also take on this role next year? There is about \$400 left in the Ed Richell scholarship fund (to attend MG college).

We need to update the names of the committee members on our MG website. Jean Meink and Leslie will get the correct names, and send them to Jennifer to update our website. Also need to make sure the latest MGPW Board minutes are there.
